LETTER JACKET REQUIREMENTS

A total of 25 points accumulated during a student's uninterrupted FFA career is required to receive a letter jacket. In addition to reaching 25 points, students must be a due paying member in good standing and maintain a current record book on the AET. It is the student's responsibility to submit a completed letter jacket application before the deadline established by the FFA Advisor each semester.

Meetings, Camps, Conventions- ½ a point per event

Volunteering- 1 point per event

Examples of volunteering include community service events, non-mandatory barn clean ups, program sales, chapter donations, etc.

Contests- 1 point per event

Examples include courtesy corps, FFA talent show, FFA rodeo, agscience fair, floral design contests, welding contests, etc.

Chapter Level- 2 points per year

District Level- 3 points per year

Area Level- 5 points per year
